**APPROVAL OF MINUTES**

Ms. Hawkins made a motion, seconded by Ms. Millis that the minutes of the September 12, 1995 meeting be approved as submitted. Passed 3-0.

**BUSINESS**

Fitness Program / Instructor Agreement – Presented by Ms. Millis, having been approved at the previous meeting. Larry Zych has indicated he will no longer act as the program director for the basketball program. Until someone else is found, the program is on hold. Efforts will be made to secure a new director.
