

Health Notes Concerning Drinking Water

drinking water is primarily from materials and components associated with service lines and home plumbing. The Town of St. John Water District is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 St. John's water testing did not detect a discernable presence of lead however, it is possible that lead levels in your home may be higher than those found in other homes in the community. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in seconds to 2 minutes before using water for drinking or cooling. If you are concerned about lead in your water, you may wish to have your water tested.
