To Our Water Customers.

The report you are about to read contains information concerning the Town of St. John water pumping and distribution systems (Monix Water Treatment Plant; Facility #IN5245043 and Gates of St. John Water Treatment Plant; Facility #IN5245043-02) for the period of January 1 to December 31, 2017. The intent of this report is briefly to summarize the quality of the water we provide to you, our water customers.

Where Your Water Comes From

St. John Municipal Water Utility is groundwater that is supplied to us by four wells that are drilled into an underground aquifer. An aquifer, quite simply, is an underground geological formation that contains water. Raw water is withdrawn from four wells and is mixed together as it travels into the water treatment plant. At the treatment plant, the raw water travels through a series of iron removal filters. Chlorine is injected to assure the water's purity and then the finished water is pumped into your home or business. During 2017, the St. John Water Treatment Plants pumped in excess of 679,110,000 gallons of drinking water.

What Your Water Contains

The sources of drinking water (both tap water and bottled water) include rivers, lakes streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, storm water runoff, and residential uses.
- Organic chemicals, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also, come from gas stations, urban storm water runoff, and septic systems.
- Radioactive materials, which can be naturally occurring or be the result of oil and gas productions and mining activities.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of these contaminants does not necessarily indicate that the water poses a health risk or that it is not suitable for drinking. Health Notes Concerning Drinking Water

St. John's water testing did not detect a discernable presence of lead; however, it is possible that lead levels in your home may be higher than those found in other homes in the community. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Town of St. John Water District is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. The Town of St. John experienced one TC (Total Coliform) violation in 2017. That location was resampled, plus samples were taken upstream and downstream. All samples retested came back absent.

ABOUT THE COVER

What is Backflow? Backflow occurs when the water in your pipes (the pipes after the water meter) goes backwards (the opposite direction from normal flow). This may cause contamination of the water supply and therefore result in the spread of unsafe drinking water. The Town of St. John will be implementing a backflow device testing program next year to help maintain safe, clean water every day to our customers.

POSTAL CUSTOMER ST. JOHN, IN 46373 This is a reminder to get those backflow devices checked annually by a licensed plumber certified in backflow testing. The Town of St. John will be implementing a backflow device testing program to make sure that the residents and commercial entities are doing their part in getting their devices checked once a year. The Indiana Department of Environmental Management (IDEM) requires municipal water suppliers to develop and implement a comprehensive cross connection control program for the elimination of existing cross connections and prevention or protection from all future cross connections.



WHO IS REQUIRED TO HAVE AN ANNUAL BACKFLOW TEST?

If your residence or building is equipped with an irrigation system, fire suppression system, a large boiler, or a business that may be a potential backflow hazard, you should have a backflow device already installed and must have your backflow preventers tested <u>once every year</u>. Backflow devices are also known as Pressure Vacuum Breakers (PVB) or Reduced Pressure Zone (RPZ) valves. These types of devices are installed onto your plumbing system to protect your drinking water and the Town's water supply from contaminants.
